



**INFORMATION RELEASE AUTHORIZATION**

("Customer") has entered into an agreement with ("Vendor") to provide certain services designed to reduce defaults by borrowers who obtained higher education loans for enrollment at Customer (the "Services").

Customer hereby requests that Nelnet release certain confidential borrower education loan account information ("Information") to Vendor and its employees, agents, and representatives through access to Nelnet's Nsight system (the "System"), and/or contact Nelnet's customer service center as Customer has authorized Vendor to represent Customer and act as the Customer's agent in performing the Services with regard to accessing the System and using the Information.

Nelnet shall revoke Vendor's access to the System on the earlier of (i) the "End Date" set forth below by Customer or (ii) upon receipt of Customer's notice to Nelnet that such access is no longer required for Vendor to render the Services as set forth in number 2 below.

1. Customer acknowledges that the Information released by Nelnet shall be limited to such data or information necessary for Vendor to perform the Services.
2. Customer agrees to provide prompt written notice to Nelnet in the event that Vendor's access to the System is not required or in the event that Vendor's authority to act as the Customer's agent or otherwise have access the Information has changed. Such notification shall include a date on which Vendor's access to the System and/or the Information is to be terminated by Nelnet.
3. Nelnet reserves the right to terminate Vendor's access to the System in the event that, in its discretion, the Vendor's access to the System or use of the Information is inappropriate, unauthorized, illegitimate or otherwise outside the scope of the purpose contemplated in this Agreement.
4. Nelnet may from time to time request confirmation of the validity of this authorization from Customer.
5. **Nelnet shall have no liability for and Customer shall be solely liable for any costs, damages, penalties, fees or the like in the event of breach, unauthorized use or access of the System or Information by Vendor.**
